Call to Order: Richard Ross called the meeting to order.

2. Review and Approval of 2/6/2025 Open Session Meeting Minutes

4. 197 Mulberry Lane, Camdenton, MO 65020 Updates

Richard Ross stated LACDC had a contract to purchase the house. Cricket Staggs stated the inspection report is due to LACDC by 3/10/2025. Title Commitment has already been received, the appraisal is due 3/21/2025, and the closing date is preliminarily scheduled for 3/21/2025. There will be no "profit" from the sale of the house. There are ongoing discussions with and data submissions to Camden County related to the ARPA funding.

Motion made by Ed Thomas, second by Ron Yarbrough, that any LACDC Board Officer can be present at the closing on the house and sign on behalf of LACDC.

5. USDA Packager Updates

Ben Holt provided updates on the USDA Packaging program. There are some new people in the process. The Board talked about having access to the CDC Loan Packaging Report.

6. Land Acquisition

The LACDC Board Officers met with an investor. The investor would like to make a difference in workforce and low-income housing in the area. Richard Ross met with the Eldon City Administrator and researched one potential property. Cricket Staggs has been looking for land as well. Richard indicated that the investor was willing to spend up to \$250,000. The Board had discussions on what the location of any purchase would need to be and the conditions related to any property. Future discussions will be needed on how to approach any potential future project.

7. Open Discussions & Other Updates

Ron Yarbrough reminded everyone that the Board needs more members who represent the low-income community.

Richard Ross asked if Board meeting recordings are posted on the website. Ed Thomas stated they can be posted on the website or stored in a Box, Dropbox, Google, or other online data storage account. Ed confirmed the written minutes and Board packets are currently posted on the website.

Richard Ross stated he will be working with Lowe's to come up with some final housing design plans for future considerations.
